### System cards

It is a BAWA requirement that matching system cards are made available by each member of a partnership at **any red point event**, including any SPBC members-only event. This helps to eliminate a lot of question asking and, hopefully, reduce the incidence of *unauthorised information*.

For those who do not have a system card, the club has a supply of simple system cards that are ideal for use by players whose system is straightforward. Completing one of these with your partner can be a great way to ensure you have a common understanding of your system and the conventions that you have agreed to play. If you have different agreements with different partners, you will need a system card for each partnership.

### From the Laws of Bridge


In the September newsletter, there was an explanation of Law 73C, about 'unauthorised information':

#### LAW 73C

When a player has available to him unauthorized information (UI) from his partner, such as a remark, question, explanation, gesture, mannerism, undue emphasis, inflection, haste or hesitation, an unexpected alert or failure to alert, he must carefully avoid taking any advantage from that unauthorized information (UI).

Here is another example, using a mistaken call, to assist with understanding how this should play out at the table:

#### Consider the bidding sequence:



East has forgotten they are playing transfers, and his 2 bid was a weak take-out which opener was supposed to pass. The alert by West has provided him with a wakeup call. He now knows they are playing transfers and tries to correct his mistake by bidding 3 , hoping his partner will get the message and pass.

Alerts and explanations are provided for the benefit of opponents, not as system reminders for the bidding side. Once East has heard the alert and explanation he is in receipt of *unauthorized information* and if his bid was not what he thought it meant, he must avoid taking any advantage of that. Therefore, in this example, to avoid using the *unauthorized information*, he should have passed the 2♥ call.

In trying to get the auction back on track with a 3 • bid, East has acted on *unauthorized information*, provided by his partner's alert. However, following East's 3 • bid, West would be expected to keep bidding because 3 • is now showing East holds five hearts and four diamonds and enough points to invite game. Therefore, the final contract should be 4 • or 3NT.

If West passes after East bids 3, you can expect the opposition to call the Director after play has finished because the cards held by the declaring side do not match the bidding – and it is reasonable for them to conclude that *unauthorized information* has influenced the bidding. The Director will determine if the score should be adjusted. The result of the 3, contract will only be allowed to stand if it is a worse score than the possible outcomes of the bids that would have been made without using the *unauthorized information*:

2♥, 4♥ or 3NT. This is to ensure that the declaring side are not permitted to benefit from taking advantage of *unauthorized information*.

Provided East passes the 2♥ bid, the Director need not be called because no one has done anything wrong. The 2♦ call was a mistake. Mistakes happen and are not infractions. The alert and explanation, if one was given, were correct.

New and inexperienced players who are still learning the complexities of bidding may sometimes make bids without fully understanding their system, which could be seen by the opposition as using *unauthorized information*. Don't be upset if the opponents call the Director. Think of it as a learning experience!

**Recommendation:** Problems such as these can often be avoided if each member of the partnership has a completed system card and checks it before the game starts.
